- Applicant agrees to be responsible for any expenses Worth Township Highway District may incur in the enforcement of the terms of this Application and Permit including construction costs, attorneys' fees and all other construction and/or litigation related expenses.
- Applicant swears the above statements are true and correct, under penalty of perjury, and that the same are made to induce the Highway Commissioner of Worth Township District to issue a Construction Permit.
- Residents, who may be affected by the improvement, will supply a notarized statement giving their approval or objection.
- Applicant will guarantee that there will be no violation of codes or covenants.
- Minimum permit fee \$25.00
- The Undersigned permittee agrees to indemnify and hold harmless Worth Township and the Worth Township Highway District from any and all claims for personal injury or property damage on the subject property related to those activities for which this permit has been secured.
- The undersigned permittee agrees to have valid insurance in effect which will afford coverage for all activities performed by permittee on the property, and that insurance shall be primary as to any claims for damages made against Worth Township or Worth Township Highway District resulting from permittee's activities on subject property.
- Contractors: Certificate of Insurance required to be on file at the Worth Township Highway Department and also a \$25,000 Bond to be held by Worth Township Highway Department until completion of job is inspected and approved by the office of the Highway Department.
