Trustee Toscas reminded everyone that the Foundation gold outing is scheduled for Friday, September 30th at Fountain Hills Golf Course.

Trustee Sexton-Kelly reported that Youth Commission will be hosting game nights Monday-Thursday. Red Cross babysitting class will be starting and the cost is \$75 for residents and \$85 for non-residents. Youth Services Bureau is continuing with telehealth and has received great reviews from counselors and parents. Sessions will now be 30 minutes long. Trustee Sexton-Kelly also mentioned that the 4th annual Trunk or Treat will be Wednesday, October 26th from 4-6 pm.

Commissioner Moody stated that the Highway Department has been busy with branch pickup, grass cutting and getting ready for the change in seasons.

Assessor Murphy informed everyone that the Board of Reviews mailing has gone out and the assessors office has received a lot of phone calls. There is still no date for appeals.

Supervisor Murphy shared that the first paint night was a huge success. There will be another session closer to Christmas and will have up to 80 people. Senior Day was also a success. 124 seniors got ID's and \$80,000 was found for residents. There will be a veterans lunch on November 10th with 100 vets attending. There are currently 2 7 passenger vans in the garage and are scheduled to start next week.
