Trustee Hurckes reported that the tuckpointing project is moving along.

Commissioner Moody shared that the Highway Department is busy with street sweeping, clearing basins, and getting ready for winter.

Supervisor Murphy announced that the Secretary of State mobile unit will be at the township on Monday, October 30<sup>th</sup> to process Real ID's. There is also a veteran's luncheon on Thursday, November 9<sup>th</sup>. 90 people are registered. She also shared that General Assistance's monthly grant amount will increase by \$50 to \$450.
